

## 2010 RIVERSIDE BANK SCHOLARSHIP PROGRAM OFFICIAL RULES

Account opening not necessary and will not increase your chance of receiving a scholarship.

### ELIGIBILITY

Scholarship Program is available only in the United States and is open only to legal residents of Riverside Bank's service area including Volusia, Brevard, Indian River, St. Lucie, Martin, Palm Beach, Okeechobee, Polk, Lake and Highlands counties. Must be a high school senior or undergraduate college student currently attending a school in the United States and accepted to an accredited post-secondary educational institution in the United States for the academic year 2010/2011. Employees of Riverside Bank and its advertising and promotional agencies and their immediate family and household members are not eligible to enter or win. Applicants are subject to all applicable federal, state, and local laws and the program is void where prohibited by law.

Recipients will be selected based on academic goals, community service and/or other information provided on application on or before 06.01.10 from all eligible entries received. Chances of receiving a scholarship will depend on the number of eligible entries received. By participating, applicants agree to be bound by these official rules and by the decisions of the selection committee, which will be final and binding in all respects. Recipients will be notified by mail, e-mail and/or telephone. Recipients must provide a valid social security number and address for tax purposes before scholarship will be awarded.
